MTAS Training - 2018



NATIONAL FLOOD INSURANCE PROGRAM ADMINISTRATION AND LEGISLATIVE TRAINING (4 CPE)

This free, 4-hour training session will provide a detailed overview of FEMA's National Flood Insurance Program (NFIP) and review the community's roles and responsibilities in administering this program at the local level. The course will contain information regarding floodway development, the components of an H&H study, no-rise certification as well as the Letter of Map Revision submittal process. The course is designed to familiarize participants with the various aspects of the duties of the floodplain manager, project engineer and the importance of compliant documentation. The class will be limited to 50 participants at each session.

Target Audience: Floodplain Administrators, Surveyors, Planning Directors, Codes Officials, Planning and Zoning Board Members and other Municipal Officials responsible for implementing their Floodplain Management Ordinance.

Managing Floodplain Development through NFIP (FEMA L-273)

Acquisition/Demolition Projects - Success Stories

City of Cleveland – Flood Mitigation Grant – 2014

The City of Cleveland applied for and received a Flood Mitigation Grant (FMA) from the National Flood Insurance Program (NFIP) in July, 2015. This award was to fund the acquisition and demolition of three severe repetitive loss structures in the Mouse Creek area of Cleveland. These properties have been acquired and demolished and project is in the final stages of completion. The properties will be deed restricted in perpetuity and will remain open space in order to restore and conserve the natural floodplain functions. Under the Flood Mitigation Assistance grant any Severe Repetitive Loss structures have a 100% cost share.

Metro Nashville / Davidson County – Flood Mitigation Grant - 2015

Metro Nashville / Davidson County applied for and received a Flood Mitigation Grant (FMA) from the National Flood Insurance Program (NFIP) in September, 2016. This award was to fund the acquisition and demolition of five severe repetitive loss structures located near the Scotts Creek Tributary, Seven Mile Creek and North Fork, Ewing Creek. These five properties are located throughout Nashville and Davidson County. 3426 Brick Church Pike is located north of Nashville. One property, Brick Church Pike intersects with Chesapeake Drive. Part of the structure lies within the floodway with the remainder of the structure in the 100-year floodplain. Two properties are located north-northwest of Nashville. One property on Buena Vista Pike intersects with Dry Fork Road with the entire structure being in the 100-year floodplain. One property on Dunbar Drive intersects with Crouch Drive. Part of this structure lies within the floodway and the remainder of the structure in the 100-year floodplain. Another property on Edmondson Pike is located south-southeast of Nashville. Edmondson Pike intersects with Briarwood Drive. The entire structure is located within the 100-year floodplain. The last property on Shadowlawn Drive is located east of Nashville in Hermitage. Shadowlane Drive intersects with Hidden Hill Drive. These properties have been acquired and being prepared for demolition. The properties will be deed restricted in perpetuity and will remain open space in order to restore and conserve the natural floodplain functions. Under the Flood Mitigation Assistance grant any Severe Repetitive Loss structures have a 100% cost share.



Tennessee Silver Jackets Team Provides Opportunities for Engagement

In September of 2014, the Tennessee Silver Jackets team signed their charter. As the team was coming together, listening sessions were held to allow every participating agency the opportunity to present their programs and supporting authorities. The meetings were held in Nashville at the operation center for the Tennessee Emergency Management Agency (TEMA), the lead agency, which is centrally located and has easy access and surface parking for everyone. At the start of the second year, the team began to move the meetings to locations proposed by team members and incorporate flood risk management tours where possible. This approach encouraged more participation, heightened interest, and attracted local groups to the meetings. The members toured a wastewater treatment facility, National Weather Service forecast center, Tennessee Valley Authority pump storage facility, and the Old Hickory Lock and Dam, and, on one occasion, organized a boat tour of the Clarksville's Riverfront and Metro Center Levee. By holding these meetings in various locations throughout Tennessee, the team has benefited greatly from the contributions of local participants. The team still returns to their home base at TEMA for convenience but strives to find a balance in meeting locations and tours to encourage interest and engagement and to create opportunities to attend for flood risk management professionals around the state.



Emergency Management & Hazard Mitigation Plans

Everyone is so busy! Nowhere is this more true than in the field of Emergency Management. Yet county Emergency Management (EM) Directors seem to take it in stride, balancing the daily administrative tasks of their offices while responding to unexpected events on a frequent basis. Easily one of the best parts of my role as a Tennessee Emergency Management Agency (TEMA) Regional Planner is working with local EM Directors on their Hazard Mitigation Plans. Few county positions have their finger on the pulse of a community the way local EM Directors do:

- They must be subject matter experts at responding to disasters, from flash flooding to hazardous material events;
- They must know and build relationships with folks at all levels of County government from the Mayor to the Road Crew, often requiring savvy communication skills; and
- Local EM Directors must be familiar with not only their county's risks as well as resources, but also those of their neighboring counties, and they need to know when and how to ask for help.

Yet no matter how busy they may be, local EM Directors understand the value of having an approved Hazard Mitigation Plan. Leveraging subject matter experts to serve on their Hazard Mitigation Committees and identifying projects designed to mitigate flooding during non-disaster allows communities to:

- Work at their own pace to have meaningful discussions about how to mitigate flood events;
- Identify projects offering long-term solutions and improve their community;
- Expedite implementation of projects once available funding sources are identified; and
- Facilitate completion of projects in the event disasters are declared.

In 2017 the TEMA Middle Region saw the counties of Cheatham, Perry, Putnam, and Wayne receive FEMA approval of their Hazard Mitigation Plans. Hickman, Stewart, Sumner, White, and Williamson counties have plans undergoing final FEMA review; and just a few of the counties currently revising their Hazard Mitigation Plans include Clay, Houston, Humphreys, Lawrence, and Maury. Each local EM Director has embraced TEMA Director Patrick Sheehan's vision of "One Emergency Management, One Tennessee" and working with other experts in their communities, local EM Directors are taking the lead in identifying cost-effective projects that will benefit their communities for years to come.

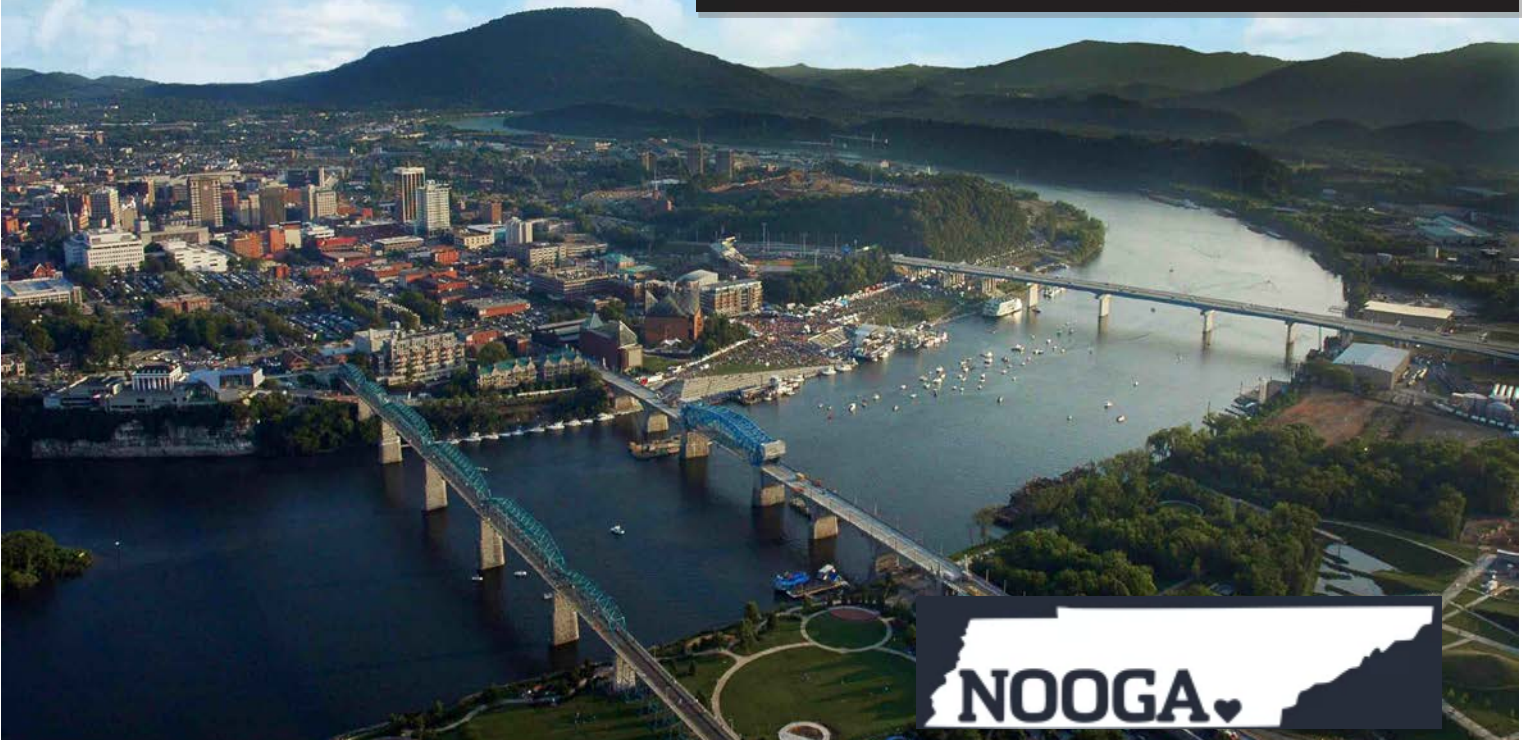
