Tennessee Mapping Update

Currently there are 4 mapping projects occurring in Tennessee under Risk MAP contracts.

Duck River:

This Physical Map Revision (PMR) encompasses 4 panels in Coffee County.

Lower Cumberland:

This PMR affects Cheatham County, Dickson County, Houston County, Montgomery County, and Stewart County. The revision covers 100 panels and a Flood Risk Review meeting is planned for February to review the draft maps with community officials.

Lower Cumberland-Sycamore:

This PMR affects Cheatham County, Robertson County, Sumner County, and Williamson County. The revision covers 48 panels and a Flood Risk Review meeting is planned for February to review the draft maps with community officials.

Stones River:

This PMR affects 56 panels in 3 counties: Cannon, Wilson, and Rutherford.

Certified Floodplain Surveyor Program



Congratulations to our newest Certified Floodplain Surveyors!

The Certified Floodplain Surveyor program was started by a joint effort between FEMA and North Carolina in 2002, to educate surveyors in submitting simple Letters of Map Change and increase the accuracy of elevation certificates. In 2017, Tennessee became the second state in the nation to offer the Certified Floodplain Surveyor certification. The program covers NFIP fundamentals, completion of elevation certificates and the concepts needed to complete Letters of Map Amendment and Letter of Map Revision based on Fill (LOMR-F). To become CFS certified, licensed surveyors must successfully complete the three-day certification seminar and 2-part exam. The class had 28 surveyors take the exam with 21 surveyors receiving certification (75% passing rate). The State of North Carolina was gracious enough to assist us with materials, instructors and guidance on the training process this year.


We will plan to have our next training event for West Tennessee on Friday, December 7, 2018. We may consider having the event in Martin or Union City.
